



Cleaning: To keep the NoteCart in good condition, clean with a damp cloth only. Do not use excessive water or other detergents to clean the product.



Usage and preparation: Before accessing the electronics compartment, kindly disconnect any power supply.

Maintenance: It is recommended to check the connecting cables regularly to ensure charging capabilities.



Transportation: Make sure to unplug the power cable from the power source before transportation. Use the cable holder to prevent any damage.
